### **New Mercury Supplier Portal**

Mercury has launched our new **Mercury Supplier Portal**, a platform where suppliers can access Mercury's various supplier applications. Designed to provide convenient access to key information and accessibility across multiple devices (desktop, mobile and tablets), from the new portal allows you to connect to:

- iSupplier: a secured site that allows suppliers to directly access information related to their business with Mercury (PO's, invoices, payments, remittance advice, contact information and business classifications). The new Mercury Supplier Portal will replace our current iSupplier log in on MercNet. Suppliers will be redirected to the new iSupplier login page if they try to log in through MercNet. Our iSupplier Portal has not changed, only the iSupplier login link. Suppliers are not able to self-register.
- EQMS: a two-way communication system between suppliers and Mercury for Audits, Certifications, Supplier Corrective Action Requests, Deviations, Change Proposals, Scorecard, Applicable Supplier Documents Supplier Guidelines, Mercury Routing Guide, etc.). The EQMS login link will not change. Suppliers are not able to self-register.
- **IBM BPM:** an application for onboarding new indirect suppliers. A request must be initiated by Mercury and an onboarding email will be sent to potential suppliers. Suppliers are not able to self-register.
- SCF RFx: an application for Mercury distribution of direct material RFQ's and supplier submission of quotations. A bid package must be initiated by Mercury and an invitation will be sent to the supplier. Suppliers are not able to self-register.

Suppliers are also able to view supplier communications and access quick links to supplier-related documentation and FAQs.

The new portal will <u>not</u> change existing supplier username and passwords to our various supplier applications. Suppliers will continue to log into our various supplier applications with their existing usernames and passwords.

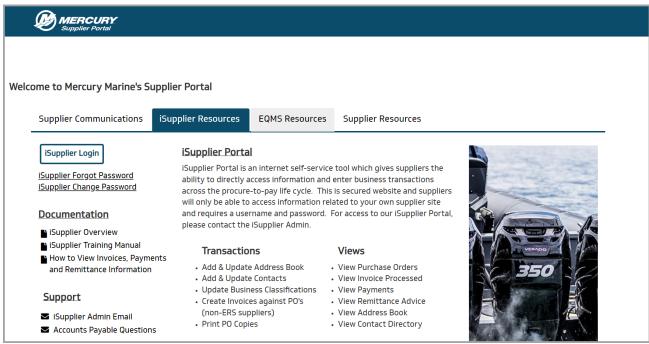
